Checking in with Education for Life, Kenya

Education for Life is a project located in Eldoret, Kenya that empowers and provides opportunities for people living with HIV and AIDS from five informal settlements: Munyaka, Kamukunji, Huruma, Kipkaren, and Langas. This is done through education, psychosocial counselling, economic empowerment and advocacy to enable beneficiaries to make life-fulfilling choices towards realising their full potential in a society that is free of discrimination and marginalisation.

Recently, EFL conducted a one-day workshop on psychosocial counselling. The participants were 30 community members who recently tested positive for HIV. The workshop aimed to enhance their capacity to cope with issues including adherence to Anti-Retroviral medication, disclosure of HIV status, stigma and discrimination. It was noted during the session that the majority of the participants attributed failing to disclose their HIV status to a fear of stigma. The session helped to increase awareness to the participants on self-acceptance and informed decision making as a stepping-stone towards positively living with HIV/AIDS.

'I am very grateful for the training I received concerning psychosocial counselling. Before the training, I had not informed my kin about my HIV status, but since then I have been able to freely talk to my sister about it. I also have plans to inform my children about my status, of course with the help of my sister with whom I have become great friends. My husband died three years ago and currently I have been taking my HIV medication. I am very grateful to the EFL group.' — Rebecca, EFL beneficiary

An additional workshop was held that focused on healthy living. The session focused on hygiene, the value of a balanced diet in promoting good health, making right choices and promoting Kitchen gardening within the families. There was increased knowledge among participants on proper hygiene in handling food, awareness on less expensive or locally available food that they can incorporate in their daily diet and how to take initiative to grow their own food like vegetables in their backyard in the local community.

ER Mission responds to COVID in Sierra Leone

The COVID-19 pandemic has impacted every aspect of life in West Africa. In Sierra Leone, which is ranked 181 out of 189 countries on the 2019 Human Development Index, the pandemic widened the level of vulnerability especially among poverty-stricken households. The country is a net importer of rice and other commodities, so the pandemic has created an exponential increase in the prices of basic food items. This added with disruptions caused by supply chain restrictions has caused untold suffering among many vulnerable households.

In response to the needs of the local communities, the West Africa Area Mission Office with a grant from ERD supported 98 households with basic food items across five communities in Sierra Leone. The food items were distributed to the households in November 2021 and included rice, vegetable oil, onions, tomato cartons and packets of spices. The Bo and Blama communities are vulnerable communities in the South-East of Sierra Leone. The Calaba Town and Hamilton communities are poverty-stricken coastal fishing communities with informal settlements. The Makeni community is a vulnerable community in the North of the country with a myriad of challenges including economic hardship. The allocation of households per community was done with consideration to the degree of need in each of the five targeted areas. Many of the households were made up of members that rely on manual labor and petty trading to survive; the pandemic restrictions severely affected their ability to earn a livelihood.

Upon receiving the distributed food items, the beneficiaries were elated and offered words of appreciation to what the food items meant to them. Miata from the Bo Community bemoaned, "You won't understand the reason behind my tears. My children and I have been living on cassava for the past one week. The last time we ate rice was on credit and I haven't paid for those cups of rice to this date. I can't believe my children and I will be eating rice, cooked with vegetable oil for the coming days. I will make sure I keep some for Christmas day. Thank you so much."

Mary from the Hamilton Community shared "I am an orphan. I have no one to rely on except God and partially my aunt who sells vegetable crops to earn a living. My suitor impregnated me and abandoned me. I am struggling with the pregnancy as my suitor is nowhere to be found. I am more worried about the time I am going to deliver. Who will be there to help me and my kid? I really don't know how to bless you Godly people for this good work".

Mamie from Calaba Town remarked, "I have never in my life bought a full bag of rice on my own. Thank you Brothers for restoring dignity to my life". Weah, a blind beggar from the Blama Community said "Brothers, you have restored my hope, at least for the coming weeks, I don't have to beg in order to have food on my table."

The intervention was impactful and it contributed to government and local communities' efforts in responding to the socio-economic chasm created by the pandemic. The Christian Brothers in the selected communities alongside the Local Chiefs and Youth Leaders implemented the grant, with the West Africa Mission Office providing oversight. We thank the ERD private donors for their generous support of this pandemic response initiative in Sierra Leone.

Edmund Rice Mission Capacity Development Project

External Evaluation

This external evaluation of the Capacity Development Project was conducted by Out of the Box Kenya in late 2021 through early 2022 to assess the relevance, effectiveness, efficiency and sustainability of the project. Out of the Box used a consultative, collaborative and participative approach to carry out this evaluation collecting data through Key Informant Interviews and Focus Group Discussions with beneficiaries and stakeholders, and a desk review of ERD project documents, plans, reports and monitoring frameworks.

The evaluation report was very positive on the progress over the four years of the project. The evaluators found 'there is a strengthened capacity in Results Based Management (RBM), finance, safeguarding, development practice and increased collaboration and networking across Mission Development Offices (MDOs).' A series of recommendations have been developed which will inform our planning for the next project phase, which included placing an emphasis on governance capacity building which is by now already underway.

2022 Progress to Date

The capacity development project has been building on the success of the governance training programme and expanding to reach more areas in Edmund Rice Mission. In May, two new governance training programmes were delivered for the Edmund Rice Ministries Foundation Philippines, Inc (ERMFPI) and for projects in the Africa Province. The Board of ERMFPI who govern the Sama-Badjao project in Leyte and the CEBU project in Cebu City received training targeted for governors. The Africa Province invited their project and mission personnel to attend training on distinguishing the roles of governors from the roles of managers. The Irish Charity Regulators Six Principles of Good Governance was used as the framework for the training, and the session also included case studies to ensure theory was tied with practice. Both trainings were very well received from attendees.

The training has been of immense benefit distinguishing between the role of governance and management. The training was very well presented, and I now feel empowered in my role as part of management team.

We look forward to working with the governors of the Africa Province, India Province and Latin America Mission Area this year to further build their capacity in governance of development projects. While the congregation chapter and subsequent provincial chapters kept them busy for much of the first half of the year, the new leadership teams plan to participate in tailored training sessions this Autumn in topics such as Human Resource Management, Financial Oversight and Sustainability.



While the Mission Capacity Support Team no longer manages the Capacity Development project, the former members of the team, many of whom are mission office personnel, desired to continue to meet to share learnings, challenges and best practices from their respective areas. The capacity development project has continued to facilitate these ER Mission Office meetings over the last two years, which have been a great opportunity to hear from voices across Edmund Rice Mission in an informal setting. Pictured above is from the December Mission Office meeting where we shared reflections from the year and rang in the holiday season.

In addition to these meetings of the ER Mission Offices, the project has facilitated two learning sessions to date this year. One was a session on Safeguarding in Edmund Rice Development projects, which was informed by the findings from the ERD Safeguarding Assessment Tool. This session gave a high level view of common patterns and challenges in safeguarding practice. In addition, a refresher training in Results Based Management was included in the ERD Funding Policy and Reporting Roll-Out training in June. We look forward to offering more of these Learning Sessions in 2022.

ERD Update

ERD Strategic Planning Process

ERD is undertaking a Strategy Renewal process in 2022, setting the vision for the next 3-5 years. On May 5 and 6, the ERD Board, Members and staff met for a two-day strategic renewal workshop. It was great to have most attendees in person for the first time in over two years!

The workshop advanced the strategic planning process, and was also a great opportunity for people to get to know each other better, and for new Board Directors and Members to learn more about the organisation. With this in mind, the two days centred on building relationships and identifying collaborative ways forward. The objectives were:



- To enable people relatively new to ERD to gain relevant insights whilst providing a refresher to those who have been involved for longer.
- To engage participants in the strategy renewal process and in doing so make meaningful progress.
- To include learning opportunities and an opportunity to strengthen relationships.


These two days built on the progress made at the ERD Stakeholder Consultation gathering, which took place on March 24. Priorities, structure and culture were all examined to see a possible way forward. We aim to finalise our strategic plan in the coming months, and will share it across the ER network.

Safeguarding in Edmund Rice Development Projects

At ERD we are committed working with our partners to ensure the protection of children and vulnerable adults from abuse, harm and exploitation. In 2021, we revised our Safeguarding Policy for partner projects. ERD Safeguarding Officer Naidi McDonnell used the opportunity to clarify compliance requirements while also aligning ERD's policy as much as possible with the policies of ERFA and Misean Cara, two of our funding partners. In order to ensure projects have the highest possible safeguarding standards, in early 2022 ERD completed an assessment of the policies and practices of 12 partner projects.

Working with a consultant Rosemary Heenan, we developed a user-friendly safeguarding assessment framework. The framework consists of a self-audit tool, which assesses the safeguarding capacity of projects in the four internationally recognised safeguarding standards: Policy, People, Procedures and Accountability. The tool allows areas of strength and weakness to be identified and a visual summary of the results is produced (example below). The tool also contains a risk assessment to identify safeguarding risks present, and assess how the project's systems mitigate these risks.

Between February and April 2022, each of the projects were assessed using the framework. Following an initial review of the project safeguarding documentation, project teams were interviewed via Zoom, using the safeguarding assessment tool to guide the interview. All 12 projects achieved an acceptable standard of safeguarding and five projects achieved exemplary status. The highest scoring across all projects was for the Accountability Standard, while projects tended to score lower for written policies. However, in the majority of projects we found that actual practice was stronger than what was outlined in the policies. The Western Cluster project in Zambia in particular was commended for quality and innovative Safeguarding practice. We look forward to working with the projects in 2022 to assist them in addressing any gaps in policies and procedures to further strengthen safeguarding across Edmund Rice Mission.
